Village of Tolono Board of Trustees Regular Meeting April 3, 2018

The Village of Tolono Board of Trustees ("Board") met on April 3, 2018. President Rob Murphy called the meeting to order at 6:31pm. Roll call found the following trustees present: Vicki Buffo, Ryan Perry, Jared Ping, Terrence Stuber and Gary Trulock. Trustee Anna Morris was absent. Also present were Clerk Brandy Dalton, Public Works Superintendent Matt Graven, Police Chief Rick Raney and attorney Marc Miller.

President Murphy led the Pledge of Allegiance. Terrence Stuber gave the invocation.

PUBLIC COMMENTS

-Roger Hayden was present on behalf of the Fire Department to ask for the ESDA truck the Village is supposed to purchase for them. They are looking for at least ½ ton, 4 X 4 and crew cab.

-Kyle Hayden spoke about the retention pond at the sewer plant. He said it needs to be closed at night and the police need to keep an eye on it. Kids have been hanging out there after dark. He also reminded everyone of the Fire Department appreciation dinner.

REPORTS

Public Works:

-Graven and Murphy had a meeting with a company that will look at systems to see if they can save us on electric.

-Graven took a part-timer with him to the Chicago area to look at plow trucks. They found one like the International already in the fleet that Graven would like to purchase.

-Graven was informed that we can go back to J&J Supply for our water meters, instead of having to buy directly from Master Meter.

Police Department:

-Chief Raney said that while he was shoveling snow, he discovered a huge crack on the steps. He has reported it to Grunloh. There is a Carbon Monoxide detector or something coming out of the ceiling in the garage. It has not been reported to Grunloh yet because he just discovered it.

Treasurer:

Officer Ahart is working on checking the status of the other properties on the nuisance list.

Trustee Perry asked Attorney Miller if Denny Davis received letters for his properties that are on the nuisance list. The Board also discussed the zoning of several properties and asked Dalton to look up the zoning on those properties.
