The Village of Tolono Board of Trustees ("Board") met on August 6, 2019. President Rob Murphy called the meeting to order at 6:31pm. Roll call found the following trustees present: Rena Anderson, Vicki Buffo, Jared Ping and Terrence Stuber. Trustees Ryan Perry and Jared Robbins were absent. Also present were Interim Police Chief Justin Levingston, Public Works Superintendent Matt Graven and Clerk Brandy Dalton.

PUBLIC COMMENTS

-Dana Tempel was present to discuss her out of the ordinary large water bill and ask what can be done. Matt Graven will re-check the meter August 12 and she will be allowed a payment arrangement.

REPORTS

Public Works:

- -Graven is working with Champaign County GIS for the survey equipment.
- -The decals for the Police Station door and Village vehicles and equipment are not the way he wants them yet.
- -The fire hydrant at the corner of Daggy and Bourne Streets was replaced today by the cheaper process. The cost will be around \$6000.
- -Graven has ordered 400 new meters. They will be here around the end of the month. He wants to start with Route 4. We still need a policy for 2nd meters for irrigation systems.
- -The PD roof was supposed to be fixed last week, but it still hasn't been done.
- -Murphy asked Graven to check to work order list and make notes if he is waiting for a reason to do things.
- -Buffo acknowledged an email they received thanking and praising Graven and Jeff Evans for fixing a sewer backup issue on a Sunday.

Police:

- -Levingston said that Officer Morgan will hopefully be finishing up background checks this week, so we can vote on hiring 2 new officers at the next meeting.
- -The camera salesman stopped by this week and is going to send new quotes.
