

**Village of Tolono Board of Trustees  
Regular Meeting  
June 2, 2020**

The Village of Tolono Board of Trustees ("Board") met on June 2, 2020. President Robert Murphy called the meeting to order at 6:33pm. Roll call found the following trustees present: Vicki Buffo (video), Ryan Perry, Jared Robbins and Terrence Stuber. Trustee Jared Ping was absent. Also present was Clerk Brandy Dalton and Police Chief Justin Levingston.

All stood for the Pledge of Allegiance. Trustee Stuber gave the invocation.

**PUBLIC COMMENTS**

Adam Munds was present to discuss RC Fest on August 8 & 9, 2020. He filled out the Special Event Permit Application.

Motion by Perry, second by Stuber to approve the Special Event Permit for RC Fest August 8 & 9, 2020 and to waive the fee. Roll call: Buffo, yes; Perry, yes; Robbins, yes; Stuber, yes. Motion passed.

**REPORTS**

**Public Works:**

- The trees near Fisher's property were taken down today.
- Regarding drainage complaints, we can pump here & there, but we can't find the blockage until we get manholes added.
- The tree at 407 N James Street is right on the border of being ours or not. Matt is going to call Ameren about taking it down since it's in the power lines.
- The June schedule board is complete in the maintenance shed.
- Matt will order the sign for recycling with the wording used by Ogden & Philo but adding our ordinance number.
- Ameren took the light off of the pole at 308 W Holden Street and told the homeowner they won't put it back without permission from the Village. Matt will contact Ameren.
- The Board wants Matt to give the office advanced notification before flushing hydrants, so the information can be pushed out through Rave, Facebook and the website.

**Police Department:**

- The stoplight was taken out by a truck Sunday night but is fixed now. There is video of it, but not close enough to get a plate number.
- In the area of Broadway and Bourne Streets, 10 cats have been caught.
- Chief Levingston is working on getting the body cameras going. He has also applied for a grant for them. It would be for the cameras only.
