# Village of Tolono Board of Trustees Regular Meeting June 16, 2020

The Village of Tolono Board of Trustees ("Board") met on June 16, 2020. President Robert Murphy called the meeting to order at 6:30pm. Roll call found the following trustees present: Ryan Perry, Jared Ping and Jared Robbins. Trustee Terrence Stuber arrived at 6:52pm. Trustee Vicki Buffo was absent. Also present was Clerk Brandy Dalton.

All stood for the Pledge of Allegiance.

#### **REPORTS**

## **Engineers:**

Motion by Perry, second by Ping to award the MFT project to Illiana Construction Company in the amount of \$193,932.50. Roll call: Perry, yes; Ping, yes; Robbins, yes. Motion passed.

- -Tim Cowan from Donohue went over the annual MS4 Stormwater Report and asked if there were any questions. He said it has been submitted to the IEPA, and he has put it on his calendar to do in May next year.
- -Cowan discussed the Water and Wastewater project plans, the cost of each part of the plans and what the estimated cost of increases would need to be in water/sewer bills to cover the payments on the IEPA loans if we were to follow through with the plans.
- -Cowan discussed the Rebuild Illinois Grant of \$5,000,000 that the Village is applying for as part of the new Sewer Plant. He suggested that we take the south side sewer extension off of the grant to gain more points.
- -Cowan said he was notified by IDOT that the Safe Routes To School Grant will be coming back in the fall, but there is no information on it yet.

#### **Public Works:**

- -The tree stump grinding quote of \$5500 will be added to the budget.
- -Matt has been making a list of trees we can and can't do ourselves. The bucket truck will cost about \$800 to \$1000 to get fixed so we can get it certified again. Ameren trimmed the tree on James Street, but they will not take it down.

Motion by Perry, second by Robbins to approve the Certified Water System Operator Contract with Ron Stabler as corrected. Roll call: Perry, yes; Ping, yes; Robbins, yes; Stuber, yes. Motion passed.

### Treasurer:

Motion by Perry, second by Robbins to approve the bills as presented. Roll call: Perry, yes; Ping, yes; Robbins, yes; Stuber, yes. Motion passed.
