

**Village of Tolono Board of Trustees  
Regular Meeting  
July 21, 2020**

The Village of Tolono Board of Trustees ("Board") met on July 21, 2020. President Robert Murphy called the meeting to order at 6:31pm. Roll call found the following trustees present: Vicki Buffo, Ryan Perry and Jared Ping. Trustee Terrence Stuber arrived at 6:49pm and Trustee Jared Robbins arrived at 7:16pm. Also present was Clerk Brandy Dalton.

All stood for the Pledge of Allegiance.

**REPORTS**

**Public Works:**

- Matt is looking into water drainage issues on the 500 block of Austin Street behind the properties in the Easement where Great Western would have been.
- Matt and Trustee Perry are both talking to people regarding tree removal.
- Trustee Perry is working on finding an air burner. The ones he was looking at are no longer available.
- Administrative Secretary Rena Anderson was present to discuss the new water meter system and answer any questions.

**Police Department:**

- There have been some speed issues and President Murphy is looking into lowering the speed limit in residential areas from 30 to 25. Chief Levingston will have to do a study before we can lower the limit. The speed limit around the parks can be lowered to 20 mph without a study.

**Treasurer:**

There was discussion regarding fines for building violations. The Board would like to see a fine for if you don't get a permit before you start building, as well as a larger fine for if you complete the project without a permit. This will be referred to the Planning and Zoning Board to complete.

Motion by Stuber, second by Buffo to enter into executive session at 7:19pm for the limited purpose of discussing the hiring, performance, compensation and/or employment of one or more Village employees 5ILCS 120/2(c)(1).
