Potential Coronavirus Exposure Information

What Kind of Risk Do I Have?

After consulting with the U.S. House of Representatives Office of Attending Physician and due to following strict Centers for Disease Control and Prevention (CDC) guidelines on social distancing, facial coverings, and hand sanitation, we do not believe you were at risk of contracting COVID-19. The CDC advises that more than 15 minutes of close contact within 6 feet puts you at risk of contracting COVID-19. You do not fall within that criteria. However, out of an abundance of caution we are sharing this information and encourage you to consider getting tested.
