AN ORDINANCE AMENDING CLASS "P" OF THE LIQUOR LICENSE ORDINANCE

WHEREAS, The Village of Tolono is charged with the health safety and welfare of its citizens which extends to public safety and the regulation of alcohol; and

WHEREAS, The Village Board of Trustees previously adopted an Ordinance creating a class "P" liquor license; and

WHEREAS, The Board of Trustees has further determined it necessary and appropriate to amend the Revised Code of Ordinances as it relates to said Class "P" license to additionally allow curbside sale of beer and wine.

NOW THEREFORE, BE IT ORDAINED by the President and Village Board of Trustees of the Village of Tolono, Illinois as follows:

Section 1. <u>Incorporation Clause</u>.

The President and Village Board of Trustees of the Village of Tolono hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance.

Section 2. Purpose.

This Ordinance is to amend Chapter 110, Section 110.040 (E), "Class P Licenses (package liquor)", in entirety, of the Revised Code of Ordinances of the Village of Tolono to additionally allow curbside sale of beer and wine.

Section 3. Amendment.

Chapter 110, Section 110.040(E), "Class P (package liquor)" of the Revised Code of Ordinances of the Village of Tolono is hereby amended to now read, in entirety, as follows:

"Class P Licenses (package liquor). Class P licenses shall authorize the retail sale on the premises specified of alcoholic liquor not to be consumed on the premises. Sales of open bottles, cans, or containers are not permitted and said bottles, cans, or containers are not to be opened on the premises. In addition to onsite sales, the within license shall allow for curbside sale of beer and wine on the premises. There shall be a limit of three licenses issued."

Section 4. Superseder and Publication.

All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded. A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

Section 5. Effective Date.

This Ordinance shall be in full force and effect upon passage and approval, as provided by the Illinois Municipal Code, as amended.
