REPORTS

Engineers:

- -Terry Boyer from Donohue gave updates on the IEPA water and wastewater loan projects. The Board will review Donohue's Wastewater Preliminary Design Agreement to be start design on the wastewater plant.
- -Boyer also said that the Risk & Resilience Assessment and Emergency Response Plan aren't due until the middle of 2021, so Donohue will get a proposal ready for that project sometime in November or December.

Public Works:

-Campus Communication Group is willing to do a Franchise Agreement with us like Mediacom has. We are working with them to get internet service at the Police Station and Village Hall. We will also supply them an area to house their equipment.

- -The Board discussed an on-call Public Works employee to answer call on the evenings and weekends. Superintendent Graven doesn't think it is needed. The Board will discuss further what to do regarding evening and weekend water and sewer issues.

Police Department:

- -Chief Levingston said the draft of the speed study is almost done.
- -Officer Gauna is back in the United States from his military assignment. Levingston is hoping he will be back to work shortly after Thanksgiving.
