#### Village of Tolono Board of Trustees Regular Meeting September 6, 2022

The Village of Tolono Board of Trustees ("Board") met on September 6, 2022 in the Police Station, located at 205 E. Main St., Tolono, IL. President Rob Murphy called the meeting to order at 6:31pm. Roll call found the following trustees present: Ann Jack Haluzak, Kyle Hayden, and Terrence Stuber. Trustee Vicki Buffo was absent. Also present was Clerk Brandy Dalton, Public Works Superintendent Connor Block and Police Chief Justin Levingston. Trustee Jared Robbins arrived at 6:49pm.

All stood for the Pledge of Allegiance. Trustee Stuber gave the invocation.

## PUBLIC COMMENTS

Gary Mitchell discussed the downtown redevelopment, saying Royce and Brinkmeyer are planning going to be doing a walk around on September 21 at 1:30pm.

Jessica Robbins discussed her work on the Safe Routes to School Grant, as well as the Illinois Transportation Enhancement Program Grant for a bike/walk path along Route 45 from County Road 600 North to Savoy. She has been working with Larry Johnson and Mike Hansen at Fehr Graham.

# **REPORTS**

**Engineering** – Larry Johnson and Mike Hansen spoke more about the ITEP Grant. Johnson also discussed the engineering for the road on County Road 1000 East between County Road 800 North and Austin Street.

**Public Works** – Trustee Robbins said there are sidewalks at Deerparth Subdivision that are offset and need to be fixed.

**Police Department** – Chief Levingston said that the new part-time officer will be starting hopefully at the end of the week. Trustee Robbins thanked the Police Department for being alert and calling residents when things are off.

**Planning and Zoning Board** – Del Boyle said that the survey needs to be sent out. The Board has updated the application and written up a fence ordinance that they will bring to the Village Board at the next meeting. Boyle has expressed concerns with Gary Mitchell on the downtown development but said the concept is good.

*Park Board* – Brian Booher reminded the Board of the joint Board meeting of both the Village Board and the Park Board on September 29 at 6:30pm at the Fire Station.
