Alex with Norfolk Southern Railroad was present to discuss closing the Bourne Street crossing. They are willing to give the Village \$50,000 and a \$150,000 Motor Fuel Tax incentive. The Board and residents present voiced their concerns.

# **REPORTS**

**Engineering** – Larry Johnson and Jessica Robbins said that they are scrambling to get letters of support for the ITEP Grant application and working on the application process, but they are making progress on it. Larry said he has talked to Connor about the MFT project problem on North Bourne Street.
