**Police Department** – Chief Levingston said that he again donated a ride to school in the squad car to a St Thomas School fundraiser. Levingston explained that in 1 year he had more calls for service than all of the other small town Chiefs combined.

Motion by Stuber, second by Robbins to enter into executive session at 7:31pm for the limited purpose of discussing the sale of land (5 ILCS 120/2(c)(6). Roll call: Buffo, aye; Haluzak, aye; Hayden, aye; Robbins, aye; Stuber, aye. Motion passed.
