AN ORDINANCE AMENDING CHAPTER 31, OFFICERS, EMPLOYEES, AND  
ORGANIZATIONS TO CHANGE PAYMENT TO OFFICIALS

WHEREAS, The Board of the Village of Tolono is entitled to payment as its elected officials in sums deemed reasonable for attendance at meetings and work on behalf of the Village pursuant to 65 ILCS 5/3.1-50; and

WHEREAS, The Village Board of Trustees previously adopted an Ordinance establishing compensation for elected officials; and

WHEREAS, The Board of Trustees has determined it necessary and appropriate to amend the Code of Ordinances as it relates to said compensation to increase compensation for elected officials.

NOW THEREFORE, BE IT ORDAINED by the President and Village Board of Trustees of the Village of Tolono, Illinois as follows:

Section 1. Incorporation Clause.

The President and Village Board of Trustees of the Village of Tolono hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance.

Section 2. Purpose.

This Ordinance is to amend Chapter 31 of the Code of Ordinances of the Village of Tolono as follows:

Section 31.04, "Payments to Officials", in entirety, to additionally increase the compensation for elected officials.

Section 3. Amendment.

Chapter 31, Section 31.04 of the Code of Ordinances of the Village of Tolono is hereby amended to now read, in entirety, as follows:

**31.04 PAYMENTS TO OFFICIALS**

(A) *Trustees.* Each Trustee shall be paid a sum of \$50 for each regular or special Village Board meeting attended by said Trustee during her or his term of office. Each Trustee taking office following the April 2025 election shall be paid a sum of \$75 for each regular or special Village Board meeting attended by said Trustee during her or his term. Compensation shall be paid on the last regular payroll of each month.

(B) *Village Board President.* The Village Board President shall be paid a sum of \$5,000 annually. Following the April 2025 election, the Village Board President shall be paid a sum of \$5,000 annually and \$75 for each regular or special Village Board meeting attended by said President during her or his term. Compensation shall be paid on the last regular payroll of each month.

(C) *Village Clerk.* The Village Clerk shall be paid a sum of \$2,500 annually. Compensation shall be paid on the last regular payroll of each month.

Section 4. Superseder and Publication.

All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded. A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

Section 5. Effective Date.

This Ordinance shall be in full force and effect upon passage and approval, as provided by the Illinois Municipal Code, as amended.


