

**Village of Tolono Board of Trustees  
Regular Meeting  
April 4, 2023**

The Village of Tolono Board of Trustees ("Board") met on April 4, 2023 in the Police Station, located at 205 E. Main St., Tolono, IL. President Rob Murphy called the meeting to order at 6:32pm. Roll call found the following trustees present: Vicki Buffo, Ann Jack Haluzak, Kyle Hayden, Jared Robbins, and Terrence Stuber. Also present were Clerk/Treasurer Brandy Dalton, Police Chief Justin Levingston, and several members of the P&Z Board.

All stood for the Pledge of Allegiance. Trustee Stuber gave the invocation.

President Murphy presented Chief Levingston with a Proclamation and gift, and he thanked him for 25 years of service on the Tolono Police Department.

**PUBLIC COMMENTS**

Daniel Grady was apologized for failing to answer a question at the last meeting and said that he will be fixing ordinances when he is seated on the Board.

Gary Mitchell said he closed on 108 E Main Street and is going to start cleaning out and fixing it this week.

Diane Anderson gave an update for the Tolono Fun Day committee.

Scott Remole said the Tolono Park District is rejecting the OSLAD Grant because there is not enough to let them qualify after they took the building out of it. They will re-apply in 2024. They are paying for a plumbing project that has to be done. Lighting is a major safety concern at West Side Park right now. The quote they got is \$385,000 and can come up with about \$250,000. They would also like to extend the Agreement for Public Works to do the mowing and fields this year. Remole said Connor has been a huge help.

***Planning & Zoning Board*** – The surveys have closed. Around 400 were received back. They will have figures at the next meeting.
