# Village of Tolono Board of Trustees Regular Meeting July 5, 2023

The Village of Tolono Board of Trustees ("Board") met on July 5, 2023 in the Police Station, located at 205 E. Main St., Tolono, IL. President Rob Murphy called the meeting to order at 6:30pm. Roll call found the following trustees present: Daniel Grady, Ann Jack Haluzak, Jacob Naas, Jared Robbins, and Terrence Stuber. Also present were Clerk Brandy Dalton and Police Chief Justin Levingston.

All stood for the Pledge of Allegiance. Trustee Stuber gave the invocation.

#### **PUBLIC COMMENTS**

Gary Mitchell said he would like to see the streetscape project happen. He would also like a sign for the Downtown Improvement Project. He said he is still interested in a TIF Fund grant.

Diane Ducey thanked the Village Board and employees for participating in the Fun Days parade. She also thanked the Board for the larger donation to Fun Days this year, as it is getting harder to get donations and volunteers. The assessment meeting will be July 13 at 6:30pm. Trustee Grady said he received good feedback of all of the Village Board and employees being out there in the parade.

### **REPORTS**

**Engineers** – Larry Johnson said that the bid opening for the MFT annual road work project was today, and there was only 1 bid. The total bid of \$268,548.50 from Illiana Construction included regular chip. If they wanted steel slate it would add about \$13,000 to the bid. **Public Works** – President Murphy said that they rocked the storm clean-up, and they even directed traffic on Route 45 by the trailer park for several hours after the power poles were snapped off by the storm.

**Police Department** – Justin Levingston said he came in for about 5 hours on his vacation day to direct traffic because of the storm damage and John Brown also came in to run calls while Levingston directed traffic. Levingston said that Fun Days went ok with no big issues. There is a prescription medicine disposal cabinet at the Police Department now where the public can drop their old or unwanted prescription medications off. Trustee Grady said that teens and kids on golf carts is becoming less of a problem. President Murphy said that there will be a band playing after the fireworks next year to help alleviate some of the traffic issues.

**Clerk/Treasurer** – Brandy Dalton said that she is trying to schedule the Fiscal Year 2023 audit, the sale of the water & sewer systems is final and the money was deposited into the money market account, and the budget ordinance is complete with the TIF numbers she figured and on the agenda to be voted on.

**Board Members** – Trustee Robbins asked about the recycling. Trustee Haluzak said she thinks we should have a study session to discuss what to do with the money from the sale of the water and sewer systems.
