### AN ORDINANCE AUTHORIZING THE DISPOITION OF SURPLUS PROPERTY

WHEREAS, the Village of Tolono, Champaign County, State of Illinois (the "Village") is a duly organized and existing Municipality created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto with full powers to enact ordinances for the benefit of the residents of the Village and the Village previously enacted the Tolono Municipal Code; and
WHEREAS, the Village of Tolono, Illinois ("Village") has the authority to declare property to be no longer necessary to the best interest of the Village and to authorize the disposal of such property in such manner as the Village may designate; and
<b>WHEREAS</b> , the personal property itemized in the list attached hereto and incorporated herein as Exhibit A has been determined to be no longer necessary to the best interests of the Village.
NOW, THERFORE, BE IT HEREBY ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF TOLONO AS FOLLOWS:
Section 1: The Village hereby declares that the personal property itemized in the list attached hereto and incorporated herein as Exhibit A is no longer necessary to the best interest of the Village and is otherwise determined to be surplus and that such property may be sold, traded or recycled by the Village Board President or his designee.
Section 2: This Ordinance shall take effect and be in force from and after its passage and publication in pamphlet form as provided by law.
