**TAX LEVY ORDINANCE OF THE
VILLAGE OF TOLONO, ILLINOIS
FOR 2025-2026**

WHEREAS, the Village of Tolono, Champaign County, Illinois is authorized pursuant to 65 ILCS 5/3-3-1 and other authority to levy real estate taxes for purposes of funding Village services and expenses; and

WHEREAS, the Board of Trustees of the Village of Tolono, County of Champaign and State of Illinois, did on the 15th day of April, 2025, A. D., pass the Annual Budget and Appropriation Ordinance; amending said Annual Budget and Appropriation Ordinance on the 15th day of April, 2025; with an additional amendment of said Annual Budget and Appropriation Ordinance on the 1st day of July, 2025 for said Village of Tolono, Illinois, for the fiscal year beginning on the first day of May, 2025 and ending on April 30, 2026, the amount of which is ascertained to be the aggregate sum of \$8,583,605.80 which said budget and appropriation bill was duly published as provided by law; and,

WHEREAS, the Village is authorized to adopt the within levy pursuant to 65 ILCS 5/8-3-1 and other applicable law; and

WHEREAS, \$8,390,355.80 will be received from sources other than real estate taxes including but not limited to other taxes, fees, grants, reserve funds and other sources, leaving the total amount of \$193,250.00 to be received from levy of taxes for said year for the following purposes and funds:

WHEREAS, consideration of the within ordinance and all other matters was made pursuant to applicable law at a duly held public meeting.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Tolono, Illinois:

SECTION 1:

That there be and is hereby levied and assessed upon all taxable property subject to taxation within the corporate limits of said Village of Tolono, Illinois, for the revenue year A. D., 2025-2026,

the total sum of \$193,250.00 for the following specific purposes mentioned in said appropriation bill and in the respective sums as follows, to-wit:

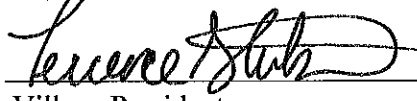
SECTION 2:

In the event that any portion of this ordinance is deemed invalid, the balance of said ordinance shall be given full force and effect to the extent allowed by law.

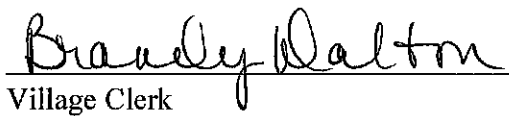
SECTION 3:
